LEAVE YOUR LEGACY OF FAITH

By Naming the National Council of the U.S., Society of St. Vincent de Paul as a Beneficiary

You can leave your Legacy of Faith by naming the National Council of the U.S., Society of St. Vincent de Paul as beneficiary of one of these assets:

- Retirement Plans such as an IRA, 401(k), 403(b), Keogh or profit-sharing pension plan
- Life Insurance Policy
- Checking or Savings Account
- Certificate of Deposit
- Commercial Annuity
- Mutual Fund or Financial Account

Here is the **simple** three-step process to name the Society as beneficiary, either as Payable on Death (POD) or Transfer on Death (TOD):

1. Contact your retirement plan administrator, insurance company, bank, or financial institution and request a change-of-beneficiary form.
2. Decide what percentage (e.g. 25%, 50%, 100%) you would like the Society to receive and name us on the beneficiary form. Include this information:

3. Return the completed form to your plan administrator, insurance company, bank, or financial institution and let us know of your intentions so we can properly thank you.

By Naming the Society of St. Vincent de Paul in Your Will or Trust

Your Will or Trust should reflect how you want your assets distributed after your death. Without this, your state of residence will implement formulas to distribute your assets. Charities will be left out, loved ones may be deeply hurt, and your final wishes will not be implemented. As you plan or update your Will or Trust, please prayerfully consider including the National Council of the U.S., Society of St. Vincent de Paul as a beneficiary to continue your Legacy of Faith and ensure your Will or Trust reflects your faith and values.

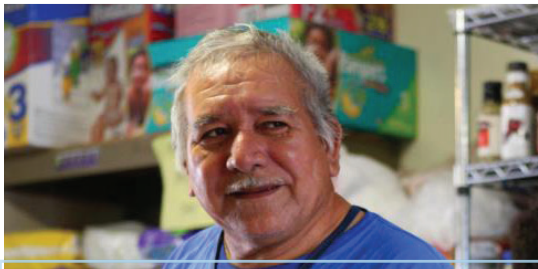
