The Story of Frédéric & Amélie



In 1833, Antoine Frédéric Ozanam was a young academic living in Paris, troubled by the suffering of the poor he saw all around him. Inspired to help, Frédéric invited five of his peers to join him in a new endeavor — a Conference of Charity dedicated to serving those in need. Shortly after founding this group, which would

soon become the Society of St. Vincent de Paul, Frédéric met and married Amélie Soulacroix.

The young couple had only 12 happy years together before Frédéric's life was tragically cut short by illness. But the impact of Frédéric's ministry had just begun. His helpmate in life as well as in death, Amélie spent the next 40 years of her life collecting and publishing her husband's writings. Thus, the impact of Society of St. Vincent de Paul and the legacy of the young man who founded it continue to live on through those who, like Amélie, commit their lives to serving those in need.

The sincere partnership between Frédéric & Amélie lasted beyond their lifetimes. Their legacy continues to be felt today. By joining the Frédéric & Amélie Ozanam Legacy Society, you too can take part in this lasting legacy of service.

If at any time it becomes impossible or impractical for my gift to be used for the above designated purpose, National Council of the United States, Society of St. Vincent de Paul, Inc. shall use my gift for a purpose and in a manner that it determines most closely meets the above designated purpose.”
